(070522) **Finance- To Approve payments for month**

Contribution to the retiring of Alan Barker at ERNLLCA will come via the chair from his annual allowance £25.00.

(080522) **Preston Patter request for funding.**

The patter provides a vital link to the community for the Parish Council and last year we agreed to increase our contribution towards the costs to £660.00 Inc. one extra edition. Costs in producing the Patter due to the cost of living crisis and the huge price rises especially around the cost of paper which has risen by 30% have forced an increase in the amount requested to £800.00; Council agreed to fund to £700.00 and suggest the extra issue is not produced during the summer.

(090522) **Ward Councillors update.**

Meeting with the Police and Crime Commissioner, the Ward Councillors and the Parish Council has been arranged for next week. The Ward Councillors are working on Local Health concerns and encourage contact with ERYC portfolio holder re concerns. PX site continue to work with Ward Councillors and advise site now full hence Pensana application outside of site , this raises concerns as to site safety especially as so close to homes .Application will come before strategic planning shortly and Cllr Dennis will be speaking to object.

Chair Cllr Ireland wished to call an extra-ordinary meeting of the Parish Council. Following discussion it was realised that this meeting was between the Parish Council and the Traffic group to advise of progress that has been made with the officers of the ERYC . As the meeting will not be open to the public it does not need to be called as an Extra- ordinary meeting and Parish Councillors are not summoned to the meeting but hopefully will attend so they are fully aware of what has been happening with regards to the traffic situation in the village.

The planning is going well with funding in place the Parish Council will match the quiz funding of £330.00 along with the ERYC grant of £500.00. We anticipate that fundraising will be in the region of £2600.00 to spend on the event. This means that the event will have all the necessary entertainment and rides and allow us to provide some free activity's/gifts to those attending. The Afternoon Tea element has been sold out.

(130522) **Preston Community Hall update.** Following a difficult two years the Hall is now open and busy with groups and activities, the Hall is in need of some decorating and support from Kier is being sought. They are struggling to get a qualified electrician at a reasonable cost- Cllr Ireland says he maybe knows a man who can help and will make enquiries on the Halls behalf.
