> A member of the public raised an issue in All Saints Mews, it is frequently used as a turning point and cars are driving excessively fast for the size and nature of the road. It was requested that a sign "Access Only" and "Caution Children" would be appropriate. This is not parish council land and signage would come under the remit of ERYC. The Clerk will write a letter to Highways at ERYC and Ward Councillors will also approach the problem from within ERYC.

> Mr Ireland, Preston Traffic Group, not that the camera in Main Street only monitors the traffic light jumpers and parking outside the take-away. The camera is not ANPR only CCTV. Plans are afoot to move the Stop line further back on Staithes Road. Middle Lane PROW was discussed as it was blocked 3 years ago. The Clerk will make enquiries about the status of the issue.

It was noted that there was no bus shelter in Preston. ERYC or PPC would be the appropriate suppliers. The Clerk will raise the matter with ERYC, specifically a shelter on Sproatley Road behind the Nags Head.
